Pegasus Vaulting Group Code of Conduct

"It is the policy of Pegasus Vaulting Club to ensure that all participants, volunteers, coaches and parents promote fair play at all times. Players are encouraged to be 'good sports' and to co-operate with and respect their team mates, coaches and officials at all times. The aim is for all vaulters to enjoy their sport, improve their skills and have FUN".

Code of Conduct

All members are asked to abide by the following rules at all times:

- Co-operate fully, respecting all requests and decisions made by the coaches, helpers, officials and administrators.
- Be on time and prepared for training sessions and competitions.
- Vaulters must control their tempers and avoid behaviour which may inconvenience or upset others.
- Treat all other participants with respect at all times.
- Be considerate to others and work as a team.
- Accept success and failure in a noble/ selfless way.
- Do not purchase or consume alcohol, tobacco products, illegal drugs of any kind or purchase dangerous articles i.e. knives whilst representing or on the club premises.
- Do not participate in any club activity whilst under the influence of alcohol or drugs.
 Members shall not promote, give or sell any drugs to another member whilst participating on the club premises or participating in any club activity.
- Take care of all property belonging to the club or any club member.
- Do not leave sessions without permission of the person in charge.
- Be responsible for caring for your own equipment, clothing and property.
- No jewellery or unsuitable clothing or footwear should be worn during any practical club sessions.
- Hair must to tied up and pulled back from the face during practical sessions.
- Do not leave any equipment, clothing, water bottles or rubbish in the vaulting shed/arena.
- On arrival to vaulting please make sure the coach has arrived before leaving children.
- On arrival please remember to be vigilant and aware of farm traffic moving around the farm.
- Please keep excess noise to a minimum when moving from the car park to the vaulting arena.
- Conditioning sheets must be handed in each week, If not handed in no horse points will be allocated to you for competitions.
- You must follow BEV and FEI rules at all times.
- Vaulters must be aware of the horse natural behaviour and act safely and sensibly around them at all time.
- Everyone in the club must help with fundraising, as all children benefit from this.
- Both children and adults must only use social media to promote Pegasus in a positive manner and must have permission from coach and all children in pictures to post on social media.

- Fees to be made by direct debt/ standing order or cash/ cheques must be in a clearly marked envelope.
- Fees must be paid by the 15th of the month or children will not be able to vault until fees are paid.

If this code of conduct is broken at anytime the child will receive a verbal warning on the coaches discretion.

If this problem persists:

The child will be asked to leave the session stage 1.

Meeting and discussion with the parents stage 2.

Child leaving the club stage 3.
